**RE: UPDATED NOTICE OF BREACH OF REGISTRAR ACCREDITATION
AGREEMENT (update to delinquent fees)**

Dear Mr. He:

Please be advised that as of 10 August 2012, Xin Net Technology Corporation ("Xin Net") is in breach of its Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 16 September 2009 ("RAA"). This breach results from:

- Failure to provide the AuthInfo codes within 5 calendar days to the Registered Name Holders of the domain names <rongzhu.net>, <qsns.net> and <zuixincn.com> pursuant to Section 5 of the Inter Registrar Transfer Policy ("IRTP").

Please refer to the attachment and chronology below for details regarding this breach. Xin Net was first notified of this breach on 31 July 2012, <http://www.icann.org/en/news/correspondence/burnette-to-he-31jul12-en>, and therefore ICANN requests that Xin Net cure the breach by 22 August 2012, 15 working days from the initial date of notification, by taking the following actions:

If Xin Net fails to timely cure this breach, ICANN may commence the termination process.

ATTACHMENT

Failure to Provide AuthInfo Codes within 5 Calendar Days

Paragraph 5 of the IRTP requires Xin Net to provide the Registered Name Holder with the unique AuthInfo code within five (5) calendar days of the Registered Name Holder's initial request. Xin Net's failure to provide the AuthInfo codes within five (5) days of the Registered Name Holders' requests concerning the domain names <rongzhu.net>, <qsns.net> and <zuixincn.com> constitutes a breach of Section 5 of the IRTP.

Below is a chronology of correspondence and other ICANN attempts to contact Xin Net to date:

Chronology:

12-Apr-12	19-Apr-12	ICANN sent first compliance notice via e-mail to admin1@xinnet.com regarding domain name <rongzhu.net>. On 17 April 2012, registrar responded and claimed, "Your domain was expired on 2012-04-12, please contact your agent to renew it first." ICANN does not consider such claim to be a valid reason for not providing the AuthInfo code to the Registered Name Holder.
15-Apr-12	20-Apr-12	ICANN sent first compliance notice via e-mail to admin1@xinnet.com regarding domain name <qsns.net >. On 18 April 2012, registrar responded and claimed "Your domain was expired on 2012-04-10, you need to renew it first and after 60 days you can ask for the transfer again." ICANN does not consider such claim to be a valid reason for not providing the AuthInfo code to the Registered Name Holder.

20-Apr-12	27-Apr-12	ICANN sent first compliance notice via e-mail to admin1@xinnet.com regarding domain name < zuixincn.com >. On 24 April 2012, registrar responded and claimed "We found that you renewed this domain recently, if you make the transfer now, we are sorry that renewal fee will not be effective. Please confirm that whether you want to transfer this domain now or wait for about 60 days to make the transfer at that time?" ICANN does not consider such claim to be a valid reason for not providing the AuthInfo code to the Registered Name Holder.
3-May-12	10-May-12	ICANN sent second compliance notices via e-mail to admin1@xinnet.com regarding domain names < rongzhu.net> and < qsns.net >. Registrar responded via e-mail on 3 May 2012, citing same invalid reason for not providing the AuthInfo codes to the Registered Name Holders.
4-May-12	11-May-12	ICANN sent second compliance notice via e-mail to admin1@xinnet.com regarding domain name < zuixincn.com>. Registrar responded via e-mail on 6 May 2012, citing same invalid reason for not providing the AuthInfo code to the Registered Name Holder.
23-May-12	N/A	ICANN attempted to contact registrar via telephone at +86 10-58022118 and +86 10 8712 8016 but was unsuccessful. ICANN contacted registrar via cell at +86 186 0111 9862 to seek clarity regarding the invalid reason for not providing the AuthInfo codes to the Registered Name Holders. Registrar advised that a new employee was handling the transfer matters and did not understand the IRTP. ICANN provided informational links to assist with

25-May-12	4-June-12	ICANN sent third compliance notices via e-mail to admin1@xinnet.com regarding the domain names < rongzhu.net>, < qsns.net > and <zuixincn.com>. Registrar responded on 28 May 2012 via e-mail, citing same invalid reason for not providing the AuthInfo codes to the Registered Name Holders.
25-May-12	N/A	ICANN attempted to fax third compliance notices to registrar at +8610 8712 7010. Faxes were unsuccessful as they could not be properly transmitted to that number.
28-May-12	N/A	ICANN staff contacted registrar via telephone. Registrar stated the problem would be handled internally.
31-Jul-12	N/A	The registrar had not provided the AuthInfo codes to the Registered Name Holders nor had the registrar provided a valid reason to ICANN for withholding the AuthInfo codes from the Registered Name Holders.
31-Jul-12		Registrar representative contacted ICANN via e-mail to acknowledge receipt of breach notice and inquire about financial non-compliance. Registrar representative stated that he was certain that registrar paid all of its fees timely.
6-Aug-12	N/A	ICANN staff contacted registrar representative via telephone and advised registrar representative that due to an error the registrar's account reflected a delinquent balance. ICANN advised registrar representative that an updated breach notice would
